3/ Effective March 27, 2025, the Regulatory Expense Surcharge will collect the rate case expense of \$475,102, which includes the expense incurred in the 2024 Arizona General Rate Case (GRC) and the remaining balance from the 2021 GRC. The balance will be recovered over a 36-month period. It applies to all Arizona customers except G-30, G-65, and special contract customers. The surcharge will be assessed on a volumetric basis and will be included as part of the rate adjustment in Footnote 4.
