Pursuant to Commission Decision Nos. 55707 and 55708, Southwest Gas Corporation submits Adjustment No. 152 to "*Taxes and Assessments on Gas Sales Not Included in Rates*".

- **City of Surprise:** Effective October 1, 2024, City of Surprise, Arizona TPT rate will increase from 2.2% to 2.8%.
