- Incentives for this program are 50% of the total cost of the audit up to the per facility (building) maximum of \$5,000 or the per customer maximum of \$50,000.
- Multiple applications for different facilities (buildings) may be submitted. Each facility (building) will be evaluated individually.
- Qualifying facilities (buildings) must be audited by a Southwest Gas approved auditor. A list of qualifying auditors
 may be found online at www.swgasliving.com/nvbusaudit or by calling 1-800-654-2765.
- Rebates are limited to no more than **one** (1) audit for each facility (building) per calendar year.
- **Builders** will be required to provide Southwest Gas Supplier Profile Form 188.0 before payment can be authorized.
- Offer is valid on qualifying energy audits performed between **January 1**, **2013 and November 30**, **2013**, or until funds are no longer available, or until the program is discontinued, whichever comes first. All applications must be post marked by December 15, 2013.
- A copy of your invoice of services performed must be submitted with this application. The invoice of services performed must include audit date, audit findings, and recommendations.
