Smart Low-Flow Showerhead

Gallons per minute (GPM) ≤ 1.5 and must have ShowerStart[™] technology. Requires natural gas water heating.

Storage Water Heater
(residential accounts are not eligible)
\$500

Thermal efficiency $\geq 95\%$ and input $\geq 199,000$ Btu/hour.

Lavatory Faucet
\$50

WaterSense[®] qualified. Requires natural gas water heating

Boiler Equipment
(residential accounts are not eligible)
\$250-\$10,000

Tankless Water Heater

Rebates are available for homes certified or for equipment purchased January 1, 2015 through December 31, 2015, or until program funds are no longer available, whichever comes first. Due to limited funding, please submit your rebate application as soon as possible after home certification or equipment purchase and installation. Homes must be certified and equipment must be installed before submitting a rebate application.

Rebate applications will be processed on a first-come, first-served basis and must be postmarked or submitted online by January 31, 2016*, whichever comes first, to be eligible for rebate.
