

SOUTHWEST GAS CORPORATION

NOTICE OF APPLICATION FILING FOR APPROVAL OF LOW-INCOME ASSISTANCE PROGRAMS AND BUDGETS FOR PROGRAM YEARS 2012 – 2014 APPLICATION NO. 11-06-019

On June 15, 2011, Southwest Gas Corporation (Southwest Gas) filed a proposed application with the California Public Utilities Commission (Commission) requesting approval of the Low-Income Assistance Programs and Budgets for Program Years 2012–2014. Southwest Gas' Low-Income Assistance Programs consist of the California Alternate Rates for Energy Program (CARE) and the Energy Savings and Assistance Program. The CARE program provides a discount on monthly gas bills to income-qualified customers at their primary residence, while the Energy Savings and Assistance Program offers energy-saving home improvements at no cost to income-qualified customers. Southwest Gas is requesting funding approval in the amounts of \$14.662.206. \$15.292.558 and \$15,960,156 for programs years 2012, 2013, and 2014, respectively.

If the Commission approves Southwest Gas' 2012–2014 proposed Low-Income Assistance Programs and Budgets, Southwest Gas will adjust its Public Purpose Program (PPP) surcharge to account for the authorized budgets. Rates will increase by approximately \$0.5 million in 2012, \$0.6 million in 2013 and \$0.5 million in 2014, to fully fund the proposed program budgets.

If the Commission approves Southwest Gas' request, the proposed rate changes will take effect on January 1, 2012, and thereafter on January 1, 2013 through 2014. The table located at the end of this notice shows the proposed percentage changes for 2012 compared to existing rates, by customer class.

EVIDENTIARY HEARINGS

The CPUC may schedule formal Evidentiary Hearings (EH's) whereby formal parties of record provide testimony and are subject to cross examination before the CPUC's Administrative Law Judge (ALJ). These hearings are open to the public to listen, but only those who are formal parties of record are allowed to participate. The CPUC has their own court reporters who will take the comments of those parties of record participating in the EH's. One of those parties is the Division of Ratepayer Advocates (DRA). The DRA consists of engineers, accountants, economists and attorneys who independently evaluate the proposals of utilities for rate changes and present their analyses and recommendations for the Commission at evidentiary hearings. Once hearings are completed, the ALJ will consider all of the evidence presented and release the proposed draft decision. When the CPUC issues a final decision, it may adopt, amend, or modify all or part of the ALJ's draft decision. The final decision may differ from the filed application.
