PROGRAM OVERVIEW

The **SHS Energy Conservation Program** assists qualified homeowners with energy conservation services at no cost to help lower utility bills by improving the energy efficiency of their homes.

TO QUALIFY: (must meet all criteria)

- ✓ Be at least 55 years old and/or disabled
- ✓ Own your home, manufactured/mobile home, condominium or townhouse
- ✓ Total annual household income below \$27,380
- ✓ Be an active Southwest Gas customer
- ✓ Home must be over 5 years of age

If homeowner qualifies, volunteer Senior Energy Consultants will visit the home, analyze its energy efficiency, and make practical conservation recommendations. As part of their consultation they will install FREE conservation materials, which may include but are not limited to **Door Sweeps, Caulking, Weather-stripping, Electrical Outlet Insulators, Smoke Detector(s) including a 9-Volt Battery, and Water Conservation Devices such as Aerators and Showerheads. If needed, referrals will be made to install Deadbolt Locks and/or Sight Glass (door viewer).** Customers will also be provided with senior assistance referrals as well as a detailed energy conservation booklet.

Once your application is reviewed and approved, an appointment will be scheduled by a call from the Energy Conservation office during the program season, October through May.
