PUBLIC NOTICE OF CONSUMER SESSION AND HEARING DOCKET NO. 12-04005

On April 4, 2012, Southwest Gas Corporation (Southwest Gas) filed an Application with the Public Utilities Commission of Nevada (Commission) for approval to adjust its rates and charges for natural gas service to all customer classes in Southwest Gas' Southern Nevada and Northern Nevada Divisions. The Commission has identified this matter as Docket No. 12-04005. The proposed annual revenue increase for the Southern Nevada Division is approximately \$25.4 million or 6.15 percent over existing total revenues, and the Northern Nevada Division is approximately \$1.5 million or 1.41 percent over existing total revenues.

Southwest Gas' request for increased revenues reflects additional costs of utility operations, not including gas costs, experienced since general rates were last changed in 2009. Three of the primary increased costs of operations are: (1) changes in Southwest Gas' cost of capital; (2) increases in expenses and capital investments; and (3) changes in the number of customers and customer volumes.
