



## **SOUTHWEST GAS CORPORATION**

### ***Quarterly Gas Cost Rate Adjustment—Southern Nevada Division***

On June 1, 2013, Southwest Gas Corporation filed a Quarterly Gas Cost Rate Adjustment with the Public Utilities Commission of Nevada. On July 1, 2013, rates for Southern Nevada customers will increase by \$0.01527 per therm. The result of this filing is an increase in annual revenues of \$5,791,696 or 2.0%.

The transactions and recorded cost of natural gas which are the basis for the quarterly rate adjustment will be reviewed for reasonableness and prudence in the next annual rate adjustment proceeding.

Monthly bills that contain usage prior to and after the effective date of the rate adjustment will be billed the applicable rate, based on when usage occurred.

The table on the back of this notice shows the change in an average monthly bill for each rate schedule. The change to individual customer bills will vary depending on the amount of gas consumed.
