



SOUTHWEST GAS CORPORATION

Annual Rate Adjustment Consumer Session and Hearing Docket No. 14-06004 – Public Notice

Southwest Gas Corporation (Southwest Gas) requested authorization from the Public Utilities Commission of Nevada (PUCN) to adjust customers' rates for both its Southern and Northern Nevada Divisions. In Southern Nevada, Southwest Gas is requesting an increase in the Uncollectible Gas Cost Expense (UGCE) of \$0.00287 per therm, a decrease in the Variable Interest Expense Rate of \$0.00285 per therm, and an increase in the Renewable Energy Program Rate (REPR) of \$0.00453 per therm. These changes result in an increase in annual revenues of \$1,879,322, or 0.49%. In Northern Nevada, Southwest Gas is requesting an increase in the UGCE of \$0.00079 per therm and an increase in the REPR of \$0.00236 per therm, which results in an increase in annual revenues of \$307,539, or 0.31%. In addition, Southwest Gas is requesting authority to modify its process for calculating its shrinkage rates and excess imbalance charges applicable to transportation service customers in Nevada.

The PUCN has scheduled a Consumer Session to provide customers an opportunity to comment on Southwest Gas' Annual Rate Adjustment filing. The Consumer Session will be held Thursday, September 18, 2014, at 6 p.m. at the PUCN's Carson City office located at 1150 East William Street, Carson City, Nevada and via videoconference at the PUCN's Las Vegas office at 9075 West Diablo Drive, Suite 250, Las Vegas, Nevada.

Evidentiary hearings are scheduled to begin Wednesday, November 12, 2014 at 10 a.m. at the PUCN's Carson City Office, and via videoconference at the PUCN's Las Vegas Office in Hearing Room A. The Hearing will continue on Friday, November 14, if necessary.

Southwest Gas' application is available for review at any Southwest Gas public office or the office of the PUCN. Interested and affected persons may file comments in writing at either of the addresses below.
