

Purpose

The purpose of this filing is to revise Rule No. 5.C – *Deposit Receipts* for clarity and to be consistent with current company practices. This filing will also update all applicable customer forms affected as a result of this change.



Background

Pursuant to Southwest's existing Rule No. 5.C, information about customer deposits is provided on receipts for cash deposits only. Southwest seeks to expand its practice and provide deposit information to those customers who pay deposits through their monthly bill statements. As such, Southwest requests authorization to update Rule No. 5.C accordingly. Southwest is also adding Form 955.1 – *Customer Receipt (Automated)* to its tariff. This form is an automated version of Form 955.0.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other schedules or rules.

Effective Date

Southwest believes this Advice Letter is subject to Energy Division disposition and should be classified as Tier 2 (effective after staff approval) pursuant to General Order 96-B. Southwest respectfully requests that the tariff sheets filed herein be made effective as soon as possible and no later than February 8, 2010.

Protest

Anyone wishing to protest this filing may do so by sending a letter within 20 days of the filing. The protest should set forth the grounds upon which it is based and should be submitted expeditiously. There is no restriction on who may file a protest. Protests should be mailed or faxed to:






