Subject: Revision No. 210

The California Public Utilities Commission (Commission) has approved Southwest Gas Corporation's (Southwest) Advice Letter No. 606 to be effective on July 1, 2000.

The attached tariff sheets reflect revisions to Southwest's line extension rules in compliance with Decision 99-06-079 issued in Rulemaking 92-03-050, the Commission's rulemaking proceeding to consider the line extension rules of gas and electric utilities in California. Rule No. 15, Gas Main Extensions, has been revised to delete Option 1, the unit cost method for pricing line extensions. Rule No. 15 and Rule No. 16, Gas Service Extensions, have been revised to emphasize the competitive bidding option for line extension construction.
