Subject: Revision No. 241 (Advice Letter Nos. 663 and 664)

The attached tariff sheets adjust rates applicable to Southwest's Southern California Division, pursuant to Commission Decision (D.) 94-12-022 requiring that Southwest's Schedule No. GS-65, Noncore Cogeneration Gas Service, be revised to track changes in Southern California Gas Company's (SoCalGas) GT-F5 cogeneration rate under Schedule No. GT-F, Firm Intrastate Transmission Service. SoCalGas' currently effective GT-F5 rates were approved by the Commission in D.01-12-018.

In addition, the monthly updates to Schedule No. GCP, Schedule No. G-CS, and the Transportation Franchise Fee Surcharge applicable to core and noncore customers for both Southern and Northern California are updated effective August 7, 2002.
