The attached tariff sheets reflect the authorization granted by the California Public Utilities Commission for Southwest to implement monthly gas cost rates for its customers in California. Such sheets reflect revised rates effective February 7, 2004, for the Gas Cost component of Schedule No. GCP.

The attached tariff sheets also reflect the following updates: (1) Core Subscription Procurement Charge Schedule No. G-CS; (2) Transportation Franchise Fee (TFF) Surcharge applicable to core and non-core customers who secure their own sources of supply; and (3) changes to Schedule No. GS-65, Noncore Cogeneration Gas Service, to track changes in Southern California Gas Company's GT-F5 cogeneration rate under Schedule No. GT-F, Firm Intrastate Transmission Service.
