Subject: Revision No. 301 (Advice Letter Nos. 748-A and 751)

The attached tariff sheets reflect the authorization granted by the California Public Utilities Commission (Commission) for Southwest to:

- 1) Revise its 2006 Public Purpose Program (PPP) Surcharge rates for Southwest's Southern and Northern California Divisions effective January 1, 2006; and
- 2) Implement monthly gas cost rates for its customers in Southern and Northern California. The attached sheets reflect 1) revised rates effective January 7. 2006, for the Gas Cost component of Schedule No. GCP, and 2) updates to the Transportation Franchise Fee (TFF) Surcharge applicable to core and non-core customers who secure their own sources of supply.
