Subject: Revision No. 058 (Advice Letter 413, Docket No. 05-5023)

Attached are revised tariff sheets filed in Advice Letter No. 413, Docket No. 05-5023, applicable to Southwest's Southern and Northern Nevada Divisions. The attached tariff sheets reflect ministerial changes to Rule Nos. 1, 5 and 13. Rule No. 1, *Definitions*, has been modified to eliminate terms no longer used elsewhere in the tariff and to make various corrections and clarifications. The modifications to Rule Nos. 5 and 13, *Bills for Service* and *Deposits*, are necessary to comply with the Public Utilities Commission of Nevada (Commission) Decision in Docket No. 05-3005, which modified sections of the Nevada Administrative code known as the Consumer Bill of Rights. The Commission approved that attached tariff sheets effective July 27, 2005.
