

Consolidated Annual Deferred Energy Account Adjustment & Variable Interest Expense Recovery Mechanism Hearing and Consumer Session Docket No. 08-05008 – Public Notice

Southwest Gas Corporation (Southwest) has requested authorization from the Public Utilities Commission of Nevada (PUCN) to adjust customers' rates. The rate adjustments Southwest is requesting in its Southern Nevada Division include: (1) a change to the Deferred Energy Account Adjustment (DEAA) to reduce it to a credit of \$0.04058; and (2) a change to the Delivery Charge to recover lower variable interest expense (VIE) related to Clark County Industrial Development Revenue Bonds. Southwest's request would result in a decrease in revenues of \$8,563,714 for the DEAA and a decrease in revenues of \$786,427 for the VIE Recovery mechanism. Southwest is also requesting authority to adjust other gas-related charges applicable to transportation customer service. **Evidentiary hearings will be held beginning Tuesday, September 30, 2008 at 10 a.m. at the PUCN Offices, 101 Convention Center Drive, Hearing Room A, Las Vegas, NV.** Video conference of the hearing will be available at the PUCN Offices, 1150 East William Street, Hearing Room A, Carson City, NV. The hearing may continue from day-to-day as necessary.

The following rate changes represent averages for each customer class. Actual changes to individual customers' bills will vary. The PUCN may set rates that are higher or lower than those proposed by Southwest or contained in this notice.
