Subject: Revision No. 293

This revision reflects the changes to the Arizona monthly gas cost rates. The October 27, 2016 monthly gas cost rate calculation utilizes the 12-month average gas cost for the period ended September 2016. In addition, the Commission provided Southwest Gas authorization to adjust its Gas Cost Balancing Account (GCBA) Surcharge in its monthly gas cost rate adjustment. The revised rates are effective October 27, 2016.
