Customers taking transportation service will pay the Basic Service Charge, the Delivery Charge per therm, and Demand Charge, if applicable, of the Currently Effective Tariff Rate for each meter included in the transportation service agreement, plus an amount of \$.00000 per therm for distribution system shrinkage as defined in Rule No. 1 of this Nevada Gas Tariff for all volumes of gas not delivered through a direct connection to one of the Company's upstream interstate pipelines, the Conservation and Energy Efficiency rate of \$.00875 per therm, and a Transportation Service Charge of \$500.00 per month per individually qualifying premise. For purposes of calculating Payment for Excess Imbalances, the Imbalance Commodity Charge is \$.22553 per therm and the Imbalance Reservation Charge is \$.31216 per therm.
