This revision reflects the changes to the Arizona monthly gas cost rates. The January 31, 2017 monthly gas cost rate calculation utilizes the 12-month average gas cost for the period ended December 2016. In addition, the Commission provided Southwest Gas authorization to adjust its Gas Cost Balancing Account (GCBA) Surcharge in its monthly gas cost rate adjustment. The revised rates are effective January 31, 2017.
