Subject: Revision No. 330

This revision reflects the following rate changes effective November 30, 2018:

- 1) The Arizona monthly gas cost rates which utilizes the 12-month average gas cost for the period ended October 2018; and,
- 2) The Gas Cost Balancing Account (GCBA) Surcharge. The Commission provided Southwest Gas authorization to adjust its GCBA Surcharge in its monthly gas cost rate adjustment.
- 3) Per Decision No. 76798 (Docket No. G-01551A-18-0080), Sheet No. 14A was added to the tariff to reflect the one-time tax credit, which ended in September 2018. Therefore, the content on Sheet No. 14A has been removed from the tariff. Also, a revision was made to Sheet No. 2 to reflect the addition of Decision No. 76798.
