Subject: Revision No. 333

This revision reflects the following rate changes effective March 4, 2019:

- 1) The Arizona monthly gas cost rates which utilizes the 12-month average gas cost for the period ended January 2019; and,
- 2) The Gas Cost Balancing Account (GCBA) Surcharge. The Commission provided Southwest Gas authorization to adjust its GCBA Surcharge in its monthly gas cost rate adjustment.
- 3) The Arizona DOT surcharge is applicable to the Transmission Integrity Management Program mandated by the Federal Pipeline Safety Improvement Act of 2002. Pursuant to A.C.C. Sheet No. 14, the DOT Safety Program Surcharge is updated annually effective the first billing cycle in March.
