Subject: Revision No. 350

This revision reflects the rate changes effective April 1, 2020:

- 1. The Arizona monthly gas cost rates which utilizes the 12-month average gas cost for the period ended February 2019.
- 2. The Gas Cost Balancing Account (GCBA) Surcharge. The Commission provided Southwest Gas authorization to adjust its GCBA Surcharge in its monthly gas cost rate adjustment.
- 3. The semi-annual gas cost adjustment applicable to Irrigation (G-80) customers authorized in Docket No. G-01551A-01-0060 by Decision No. 63598.
- 4. The removal of the El Paso Natural Gas Credit due to the fulfillment of the refund to customers.

For customers converting from sales service, an additional amount equal to the currently effective Gas Cost Balancing Account Adjustment will be assessed for a period of 12 months.
