Public Utilities Commission of the State of California

**Subject: To update procurement charges applicable to Schedule No. GCP for core customers and the Transportation Franchise Fee (TFF) and Transportation Distribution Shrinkage (TDS) Surcharges applicable to core and noncore customers in Southwest Gas' California service areas.**

Southwest Gas Corporation (Southwest Gas) hereby submits for approval by the California Public Utilities Commission (Commission) revisions to its California Gas Tariff. The tariff sheets being modified as a result of this submission are listed on Attachment A.

**Purpose**

The purpose of this routine monthly submission is to revise the attached tariff sheets by updating: (1) procurement charges applicable to Schedule No. GCP, Gas Procurement for Core Customers, in compliance with the California Public Utilities Commission's (Commission) letter dated October 20, 2000, approving Southwest Gas' Advice Letter No. 619; (2) the Transportation Franchise Fee (TFF) Surcharge applicable to core and noncore customers who secure their own sources of supply, pursuant to Public Utilities Code, Sections 6350 to 6354, *et seq*; and (3) the Transportation Distribution Shrinkage (TDS) Charge, in accordance with Decision (D.) 14-06-028.

For core sales customers, the July 2020 cost of gas, including adjustment for franchises and uncollectibles, is \$0.16540 per therm for Southwest Gas' Southern California Service Area and \$0.16029 per therm for Southwest Gas' Northern California and South Lake Tahoe Service Areas.

The July TFF Surcharge rate is \$0.00186 per therm for Southwest Gas' Southern California Service Area and \$0.00209 per therm for Southwest Gas' Northern California and South Lake Tahoe Service Areas.

The July TDS Charge is \$0.00126 per therm for Southwest Gas' Southern California Service Area and \$0.00090 for Southwest Gas' Northern California and South Lake Tahoe Service Areas.

This results in an decrease in rates of 1.25% for Southern California, 2.06% for Northern California, and 2.71% for South Lake Tahoe customers.

### **Effective Date**

Advice Letter No. 626 authorized Southwest Gas to make its monthly gas cost adjustment effective between the first and seventh calendar day of each month. This Advice Letter is subject to Energy Division disposition and should be classified as Tier 1 (effective pending disposition) pursuant to General Order (GO) 96-B. Southwest Gas respectfully requests the rate adjustments become effective July 1, 2020.


