Subject: Revision No. 367

This revision reflects the rate changes effective May 1, 2021:

1. The Arizona Monthly Gas Cost (MGC) rates which utilizes the 12-month average gas cost for the period ended March 30, 2021.
2. The Gas Cost Balancing Account (GCBA) Surcharge. The Commission provided Southwest Gas authorization to adjust its GCBA Surcharge in its monthly gas cost rate adjustment.
3. The distribution shrinkage.

Southwest Gas Corporation (Southwest Gas) has also removed the mention of the one-time bill to consumers authorized by the Arizona Corporation Commission (Commission) in Decision No. 74595 on Sheet No. 14A of the Statement of Rates.

The following changes should be made in your copy of Southwest Gas' Arizona Gas Tariff No. 7:
