- 1. The Arizona Monthly Gas Cost (MGC) rates which utilizes the 12-month average gas cost for the period ended July 31, 2021.
- 2. The Gas Cost Balancing Account (GCBA) Surcharge. The Commission provided Southwest Gas authorization to adjust its GCBA Surcharge in its monthly gas cost rate adjustment.

For customers converting from sales service, an additional amount equal to the currently effective Gas Cost Balancing Account Adjustment will be assessed for a period of 12 months.
