Subject: Revision No. 378

This revision reflects the rate changes effective March 1, 2022:

1. The Arizona Monthly Gas Cost (MGC) rates which utilizes the 12-month average gas cost for the period ended January 31, 2022.
2. The Arizona Department of Transportation (DOT) Safety Program Surcharge which is applicable to the Transmission Integrity Management Program mandated by the Federal Pipeline Safety Improvement Act of 2002. Pursuant to A.C.C. Sheet No. 14, the DOT Safety Program Surcharge is updated annually effective the first billing cycle in March.
3. The Vintage Steel Pipeline (VSP) surcharge. The VSP replacement program was approved in the company's last general rate case. This program allows Southwest Gas to replace pre-1970's VSP on a proactive and accelerated basis in Southwest's Arizona jurisdiction.

For customers converting from sales service, an additional amount equal to the currently effective Gas Cost Balancing Account Adjustment will be assessed for a period of 12 months.
