Subject: Revision No. 411

This revision reflects the rate changes effective January 1, 2025:

- 1. The Arizona Monthly Gas Cost (MGC) rates which utilizes the 12-month average gas cost for the period ended November 2024.
- 2. The Gas Cost Balancing Account (GCBA) Surcharge. The Commission provided Southwest Gas authorization to adjust its GCBA Surcharge in its monthly gas cost rate adjustment.

- 1/ All charges are subject to adjustment for any applicable taxes or governmental impositions.
- 2/ Customers taking transportation service will pay the Basic Service Charge, the Commodity Charge per Therm less the Monthly Gas Cost, and Demand Charge, if applicable, of the Currently Effective Tariff Rate for each meter included in the transportation service agreement, plus an amount of \$0.00282 per therm for distribution shrinkage as defined in Rule No. 1 of this Arizona Gas Tariff. The shrinkage charge shall be updated annually effective May 1. For customers converting from sales service, an additional amount equal to the currently effective Gas Cost Balancing Account Adjustment will be assessed for a period of 12 months.
- 3/ Effective March 1, 2023, the Regulatory Expense Surcharge will collect the rate case expense up to \$400,000 incurred in the 2021 Arizona General Rate Case. The balance will be recovered over a 48-month period. It applies to all Arizona customers except G-30, G-65, SB-1, and special contract customers. The surcharge is \$0.01 per customer per month.
