The shrinkage charge shall be updated annually effective May 1. For customers converting from sales service, an additional amount equal to the currently effective Gas Cost Balancing Account Adjustment will be assessed for a period of 12 months.

3/ Effective March 1, 2023, the Regulatory Expense Surcharge will collect the rate case expense up to \$400,000 incurred in the 2021 Arizona General Rate Case. The balance will be recovered over a 48-month period. It applies to all Arizona customers except G-30, G-65, SB-1, and special contract customers. The surcharge is \$0.01 per customer per month.
